Lack of resources for Spanish speaking clients to have materials (such as legal and medical) translated. We have two outreach Spanish speaking staff, however the need is far greater than we are able to handle, because of other advocacy work. There are very few options for survivors with serious physical and/or mental disabilities. As a result they are in vulnerable situations and are at higher risk of additional assaults. The deaf community is very small in our area, and it takes a great deal of time and resources to develop trust among them. This creates a barrier, and also in many instances the abuse is occurring with another person in their community. So the survivor does not want to report the abuse.

Translation has been an issue in providing services and finding resources for victims, many fear they or there family will be deported and do not like to engage law enforcement or the justice system

Depending on the victim, the order of the barriers could look very different. There are LGBTQ people who don't speak English who may experience language as their utmost barrier. A trans survivor would have different barriers than an individual who is gay or lesbian. There are LGBTQ individuals that live in poverty and some that are middle class. It is almost impossible to do a broad categorization of barriers.

Language barriers and financial barriers are the most consistent barriers.

Lack of funding for cultural Specific agencies, to provide services to monolingual Spanish speakers participants.
