INDICTMENT

The above-named defendant is accused by the Grand Jury of Multnomah County by this indictment of the crimes of FALSE STATEMENT UNDER THE ELECTION LAWS, ORS 260.715(1), and ORS 260.993(2), Class C Felony, committed as follows:

COUNT 1
False Statement under the Election Laws

Defendant, on or about May 30, 2010, in Multnomah County, Oregon, did unlawfully and knowingly make a false statement when a statement was required under the election laws of the State of Oregon, by signing as the circulator of signature sheet number 7516, beginning with the name "Donna Lindgren" on line #1, for state initiative petition number 70, and thereby by signing as the circulator of signature sheet and falsely certifying that every person who signed the sheet did so in defendant's presence and that defendant believed that each such person was a qualified voter in the State of Oregon, to wit: that Robert Glass signed the petition in his presence when he did not.

False Statement under the Election Laws

2 Defendant, on or about May 30, 2010, in Multnomah County, Oregon, did unlawfully and
3 knowingly make a false statement when a statement was required under the election laws of the
4 State of Oregon, by signing as the circulator of signature sheet number 7516, beginning with the
5 name "Donna Lindgren" on line #1, for state initiative petition number 70, and thereby by
6 signing as the circulator of signature sheet and falsely certifying that every person who signed
7 the sheet did so in defendant's presence and that defendant believed that each such person was a
8 qualified voter in the State of Oregon, to wit: that Mary Lou Vuylseke signed the petition in his
9 presence when she did not.






