Reporting Period - January 1, 2016 – December 31, 2016

General Grant Information

- Information for this report was submitted by 53 individual subgrantees for the January 1, 2016 – December 31, 2016 reporting period.
- Three (5.7%) subgrantees were faith-based organizations.
- Ten (18.9%) subgrantees were culturally-specific community-based organizations.
- 12 (22.6%) subgrantees reported using STOP Program funds for projects that specifically addressed tribal populations.
- Dual programs, Domestic violence programs, and Tribal sexual assault and/or domestic violence programs were the types of organizations most frequently using STOP funds. The following is a complete list of the types of funded organizations:

Victim Services

During the 12-month reporting period, STOP Program subgrantees provided services to 6,614 victims/survivors² of sexual assault, domestic violence, dating violence, and stalking to help them become and remain safe from violence.

The following were the barriers most frequently reported by the subgrantees as reasons victims/survivors were not served or were partially served:

- Program reached capacity
- Program unable to provide service due to limited resources/priority-setting
- Services not appropriate for victim/survivor
- Services inappropriate or inadequate for victims/survivors with mental health issues
- Program rules not acceptable to victim/survivor
- Services inappropriate or inadequate for victims/survivors with substance abuse issues

Shelter services

- 752 victims/survivors and 608 family members received a total of 33,301 bed nights in emergency shelter.
- 18 victims/survivors and 15 family members received a total of 3,410 bed nights in transitional housing.

Hotline calls

- 9,409 hotline calls were received from primary victims/survivors.
- A total of 14,681 hotline calls were received.

Victim-witness notification/outreach to victims/survivors

- 2,342 notification/outreach services were provided to victims/survivors.

Protection orders

- Of the protection orders⁸ for which victim services staff provided assistance, 1,602 orders were granted for domestic violence/dating violence victims/survivors; 35 orders were granted for sexual assault victims/survivors; and 71 orders were granted for stalking victims/survivors.
