

Common Requirements for All 2019-2021 Joint Non-Competitive Grant Funds

Common requirements for recipients of CVSSD's ODSVS, VOCA and VAWA funding were outlined in the 2019-2021 Joint Non-Competitive Grant Funds Request for Applications. As stated in the common requirements, organizations must:

- Provide direct services as outlined in the RFA;
- Provide meaningful access to services;
- Participate in planning to inform the development of programs and services;
- Engage the community in planning processes and to enhance outreach to survivors, especially those who have not accessed services before; and
- Establish lead positions for specific populations and sexual assault when applicable.

Please answer the following questions for the six-month reporting period (July 1 to December 31 or January 1 to June 30):

1. What is the organization currently doing to examine its own practices and policies to ensure services to survivors are **culturally responsive**? Describe ways the organization supports staff in recognizing their own biases when working with survivors from culturally diverse backgrounds.
2. An organization must directly link survivors whose needs are beyond their expertise to an appropriate partner program/organization when one exists and is available. How have **referrals** changed or improved since the last reporting period?
3. What **planning or assessments** are happening within your organization to improve programs and services? How were representatives of underserved, marginalized, and oppressed communities and Tribal Nations included? If available, upload recent planning reports.
4. How has your organization been recently involved in **community coordination** efforts? This may include 1) participation on state or local multidisciplinary teams, 2) presentations or trainings your organization offered or received from other partners, and 3) collaboration or formal partnerships with community groups, including underserved, marginalized, and oppressed communities and Tribal Nations.
5. If applicable, describe the activities of the **population specific lead position**. How was information about the specific population shared with others in the organization? How has the lead position participated in community efforts to address the needs of the specific population? What trainings about the specific population did the lead position attend?
6. If applicable, describe activities of the **sexual assault lead position**. How was information about sexual assault shared with others in the organization?? How has the position participated in community efforts to address sexual assault? What trainings about sexual assault did the lead position attend?
