¹ The purpose of the Campus Advocacy and Outreach funding initiative is to support Oregon’s eligible two-year, four-year, public, non-profit, and community colleges in enhancing and expanding established qualified victim services programs. Funding is intended to support outreach activities and the expansion of advocacy services to victims of gender based violence on Oregon’s campuses.

² The purpose of this funding initiative is to expand or enhance direct services provided by CASA advocates to children who are victims of child abuse in the first year following the victimization or the CASA appointment. CVSSD accepted applications from CASA lead programs on behalf of twenty-three affiliate CASA programs. A lead program is the program that submits a single application on behalf of one or more programs, called affiliate or subrecipient programs in this context. Funding is intended to support FTE and activities for direct case management and advocate supervision and for volunteer advocate recruitment and training.

³ The purpose of the Community-Based Advocacy and Healthcare Partnerships funding initiative is to expand the delivery of community-based advocacy services to survivors of intimate partner violence (IPV) through partnerships with local health care providers, clinics and systems. This is an opportunity for non-profit domestic and sexual violence (D/SV) advocacy organizations to apply for projects that establish partnerships with health care systems including, *but not limited to*, public health departments, Federally Qualified Health Centers, primary care clinics, school based health centers, and hospitals. These projects will offer community-based advocacy services for survivors of IPV who are receiving health care services from one or more of the project's established health care partners.

⁴ The purpose of this funding initiative is to support coordinated activities that facilitate direct service delivery, including the development and enhancement of multidisciplinary county-wide human trafficking task forces that implement collaborative approaches for victims of child and youth sex trafficking. Funding is intended to support FTE and activities for the position of a Human Trafficking Task Force Coordinator/Advocate.
