CULTIVATING INTEREST, ANTICIPATING BARRIERS

Instructions:

1. Identify a spokesperson who will report back to the larger group. Each group will have one minute to share their responses to the two questions listed below.
2. As a group, you'll be talking about delivering the Understanding and Address Sex Trafficking training to the medical community
3. Review your group's community readiness description and keep it in mind while answering the following questions:
 - a. What barriers do you anticipate?
 - b. How might you address these barriers?

Group 1: Your medical community is ready and already knocking on your door. Make no mistake! Even when a community seems ready, you will still encounter barriers.

Group 2: A nurse in your community reaches out to see if training is available; however, they don't have a commitment from executive staff yet.

Group 3: No one from your medical community has asked for trafficking training. The readiness of the medical community is unclear

Group 4: A nurse in your community tells you they want hospital staff to receive training on how to identify and work with victims of trafficking. They say they don't need a basic training because they received a training from another group. You're familiar with the other group. Their training is not trauma-informed, and it sensationalizes trafficking. You'd like to begin with the UAST training before moving to the more skill-specific training.
