Request For Your Consent to Electronic Payment Withdrawal

Why am I receiving this request?

As an obligee or child attending school, your consent for electronic payment withdrawal is required.

- This request is being sent to you because the obligor has asked to enroll in our electronic payment withdrawal service.
- The Oregon Child Support Program must get your written agreement to approve this application.

What happens when I provide consent for the electronic payment withdrawal service?

- The obligor will be allowed to pay support directly from their bank account.
- Once the application is approved, we take the support amount out of their bank account on the same day(s) each month. Your payment should arrive around the same day(s) each month, depending on holidays and weekends.
- Payment by electronic payment withdrawal will replace income withholding.

What happens if I decline to provide consent for electronic payment withdrawal service?

- If there is a wage withholding currently in place, it will remain in place.
- The obligor may reapply for electronic payment withdrawal after six months.

What if there are insufficient funds in the designated bank account?

- If we are unsuccessful in securing the funds within 30 days, the electronic payment withdrawal may be cancelled.
- If the electronic payment withdrawal is cancelled, a wage withholding will be issued.

What if there is a modification to my child support case?

• The electronic payment withdrawal application allows us to change the withdrawal amount at any time in the future, if your case is modified or your support amount changes.

What about health care coverage?

Payment by electronic payment withdrawal will replace income withholding only for the payment
of support. Health care coverage premiums (if any) will still be withheld from the obligor's
wages.

What if I change my mind?

- You may ask that income withholding be reinstated if the withholding would be in the best interest of the child. For income withholding to be reinstated, the Oregon Child Support Program or a circuit court would need to:
 - Approve your request, and
 - Make a finding that income withholding is "the method of payment likely to produce consistent support that will reach the child(ren) in the most expedited manner." OAR 137-055-4060 and OAR 137-055-4080.

If we do not receive your consent within 90 days from the date of this letter, we will reject the application. This means that the obligor will not be allowed to use electronic payment withdrawal as their payment method.
