Lisa has worked in the domestic violence and sexual assault field for over 23 years addressing violence against Native American and Alaska Native women. Ms. Brunner has advocated on the local, state, national, and international levels to bring about change to public policy to address violence against Native women, men, and children.

She has served at the United Nations, including five years at the Permanent Forum on Indigenous Issues and participated in the Global Indigenous Women's Caucus and a panel on violence against Indigenous Women of North America. She was invited to Vienna, Austria to present on "Addressing Hate Crimes against Indigenous Peoples: Expert Meeting on the Situation in the Organization for Security and Co-operation in Europe (OSCE)," Office for Democratic Institutions and Human Rights (ODIHR).

She testified on "Violence Against Native Women in the United States" before the Inter-American Commission on Human Rights. Lisa has also testified before the U.S. Congress on "Combating Human Trafficking: Federal, State, and Local Perspectives" for the Committee on Homeland Security and Governmental Affairs.

Lisa is also a founding member of the National Congress of American Indians, Violence Against Women Task Force. Lisa has also been featured in publications such as *The Inter-American Human Rights System-Handbook*, and *National Museum of American Indians Magazine*, and is published in the journal, *Psychology of Violence*.
