#### Welcome and Introductions

Robin welcomed everyone, and each member introduced themselves.

#### Membership Discussion about what motivates participation in the CJA task force.

Each member shared what motivates them to participate in the CJA task force.

#### **Three Year Assessment Discussion**

Robin provided a brief overview of the last three-year assessment process.

• The first step was having each member of the task force identify three stakeholders in their constituency to reach out to for their perspective about the needs of children related to investigation, prosecution, and judicial handling of child abuse and neglect in Oregon. Members were given a questionnaire to provide some guidance and structure for the conversations. The questions included identifying weaknesses, strengths, trends and suggestions for improvement in investigation, prosecution, and judicial handling of child abuse in Oregon.

- Second, task force members synthesized this information into field reports which incorporated the feedback and the member's perspective.
- Third members met in smaller groups organized by role to discuss the information they gained from their conversations and shared themes with the whole task force.
- Next, a survey was created and distributed to a larger group of stakeholders statewide to gather wider input.
- After the survey, all the information that was provided was used to create the three-year priority.

Robin shared feedback about process from the last three-year assessment. Members shared challenges in identifying appropriate stakeholders for some groups as well as responding to questions about processes with which some groups had less knowledge (eg a parent responding to investigation). There were suggestions from the group that the group as a whole might help identify individual stakeholders and that questions might be customized for the particular type of constituent. The group also identified an interest in collecting and reviewing existing sources of information and data related to child abuse intervention and suggested that the statewide field survey be conducted prior to the small group reports.

# Presentation from Amelia Sider from Western Regional Childrens Advocacy Center (WRCAC).

Amelia Siders from WRCAC presented information on rural mental health challenges across the region, how CACs are responding, and promising emerging practices. She also shared how WRCAC is helping CACs with training, support, collaboration, and resources. Amelia shared general information on the difficulties the United States is facing with not having enough mental health providers, especially those that primarily work with children and youth. Most of them are facing high caseloads. Rural communities also face ongoing challenges with Wi-Fi access which impacts availability of telehealth. Amelia's role is to support the chapters in the region across the country that support mental health work and to be able to help CACs provide mental health services.

WRCSC is planning to release a tele-mental health readiness report by the end of September or the beginning of October. This will be an implementation resource guide for chapters. Also, the WRCSC website will be updated at the beginning of 2024 with tele-mental health resources for CACs. They will continue quarterly mental health peer consultation, which is open nationally and is in partnership with the National Children's Alliance. They are launching on October 7th, 2023, a consultation forum for advocates and mental health. They are working on a guide for CACs on how they meet the mental health standards.
